## ORDER

## Sub :- Revision in the Wages and Allowances of Registered Security Guards/Officers of the Board w.e.f. 1st May, 2023.

As provided under Clause 30 of the Private Security Guards (Regulation of Employment & Welfare) Scheme (Amended) 2002, the Security Guards Board is empowered to revise and fix the Wages & Allowances in respect of Security Guards/Officers registered with the Board. For fixation of the Wages of the registered Security Guards, the Board has adopted the policy to fix the Wages as per the Wages fixed under the provisions of Minimum Wages Act, 1948, which are applicable to the "Shops & Establishment". Accordingly, the registered Security Guards are paid Special Allowance, which is declared by the State Government for the said scheduled employment, from time to time. The Wages of the Security Guards are revised from time to time, after considering the demands made by the Trade Unions representing the Security Guards are Rs. 20,931.00.

The various Security Guards Unions vide their representations submitted to the Board, had demanded to increase in rates of Wages & Allowances of the registered Security Guards of the Board. As provided under Sub-Clause (2) of Clause 30 of the Private Security Guards (Regulation of Employment & Welfare) Scheme, (Amended) 2002, for the purpose of fixation of the rates of Wages & Allowances for the registered Security Guards of the Board or for revising the same the Board had published a Public Notice in the Daily Newspaper, 'Loksatta', 'Mumbai Sakal', 'Indian Express' & 'Pudhari' dtd. 3.12.2020 appealing to submit their proposals, within a period of 7 days.

Taking into consideration the Suggestions and objections received from the Principal Employers and the representations of Security Guards Unions, the Committee formed on 8.6.2022 as per the Government Orders, had submitted report on 22.9.2022.

The Government vide it's letter No. Security/Wage Revision Proposal/2023/Desk-14-163, dtd. 9.5.2023 has accorded sanction and directed the Board to revise the Monthly Wages & Allowances of the Registered Security Guards of the Board within framework of the Relevant Acts and as provided under Clause 30 of the Private Security Guards (Regulation of Employment & Welfare) Scheme (Amended) 2002. Accordingly, the Board has vide it's Resolution dtd. 16<sup>th</sup> May, 2023 taken a decision to revise the Wages & Allowances of the registered Security Guards/Officers, w.e.f. 1<sup>st</sup> May 2023 for next 3 years as under. -2-

The said revised rates will be applicable to all the registered Principal Employers within the jurisdiction of the Brihan Mumbai, Thane District & Palghar area w.e.f. 1st May, 2023.

## Special Allowance/Dearness Allowance: 2)

Special Allowance applicable to schedule employment of "Shops & Establishment" under the provisions of Minimum Wages Act, 1948, will be applicable to the Registered Security Guards/Officers of the Board.

The Competent Authority, under Minimum Wages Act, 1948 vide its Order declared the rates of Special No.RW/MWA/SA/2023-(1)/Desk-10, dtd. 1.2.2023 Allowance/Dearness Allowance for the period from 1st January, 2023 to 30th June, 2023 @ Rs.2,444.00. The same Dearness Allowance is applicable to the registered Security Guards of the Board.

House Rent Allowance: 3)

In addition to Minimum Wages (Basic Wages + Special Allowance/Dearness Allowance) mentioned above, Monthly House Rent Allowance is made applicable at the rate of 20% on the Minimum Wages payable to the Registered Security Guards/Officers of the Board.

The Wages and allowances due to the Security Guards are for 8 Hrs. duty and the 4) payment of extra duty, should be calculated at double the normal rate of minimum wages (Basic Wages+ Special Allowance/Dearness Allowance).

No changes have been made in the present Conveyance Allowance, Washing Allowance 5) and Leave Travelling Allowance.

6) No changes have been made in the present allocation or rate of the levy. Levy @ 45.25% is payable on the Minimum Wages (Basic Wages + Special Allowance/Dearness Allowance) & Levy @ 3.25% is payable on H.R.A., Leave Travelling Allowance and Extra-Duty Wages.


