ORDER

Sub :- Regarding Special Allowance/Dearness Allowance & H.R.A. w.e.f. 1st July, 2025.

The Board had revised the Special Allowance/Dearness Allowance and House Rent Allowance of the registered Security Guards/Officers w.e.f. 1st January, 2025 vide this Office Order No.SGB/DA/ALD/2025-1216, dtd. 24.02.2025.

The Competent Authority, under Minimum Wages Act 1948, Mumbai, vide its Order No.RW/MWA/SAJULY-DEC./2025(2)/Desk-10/8008, dtd. 04.08.2025 declared the rates of Special Allowance/ Dearness Allowance for the period from 1st July, 2025 to 31st December, 2025 @ Rs.3,614.00 p.m. In accordance to this the Board has decided on 5.08.2025 to revise the Special Allowance/Dearness Allowance and House Rent Allowance payable to the Registered Security Guards/Officers of the Board for the period from 1st July, 2025 to 31st December, 2025. Accordingly the rate of Special Allowance/Dearness Allowance of the Security Guard/Officer is Rs.3,614.00 p.m.

House Rent Allowance @ 20% on Minimum Wages (Basic Wages + Special Allowance/ Dearness Allowance) is also made applicable to the Security Guards/Officers. The rate of Basic Wages, Conveyance Allowance, Leave Travelling Allowance (LTA) & Washing Allowance will remain same as per the Order of the Board Ref. No.: SGB/Chairman/2023-2467, dtd. 16th May, 2023.

All the registered Employers who are availing services of the Registered Security Guards of the Board are hereby directed to remit the Wages and Allowances to the Board of the above 4 Categories from 1st July, 2025 at the above rate along with the Levy @ 43.10% on Minimum Wages.

The Extra Duty Wages should be calculated double the normal rate of minimum wages (i.e. Basic Wages + Special Allowance/ Dearness Allowance) for all Categories.

Security Personnel who are out of the scope of ESIC Scheme, the Board has decided to apply the Scheme of Workmen's Compensation Act, 1923.

The Board is registered with Maharashtra Labour Welfare Board on behalf of all Registered Principal Employer of the Board.

The Wages fixed by the Board are for 8 hours duty per day inclusive of weekly off.

The Wages, Allowances and Levy thereon from 1st July, 2025 should be remitted on the basis of above rates of wages and allowances on or before 4th day of the following month.
